Explanation of Responses:

1. On August 23, 2005, Woolley Storage LLC, which was the holder of 292,641 shares (the "Shares") of the Company's common stock, dissolved, and made a liquidating distribution whereby the Shares were distributed to the members of Woolley Storage LLC. As was previously indicated in Mr. Woolley's Form 3 filed August 11, 2004, Mr. Woolley was the non-member manager of Woolley Storage LLC. He did not receive any shares in the liquidating distribution. Mr. Woolley previously reported indirect ownership of these shares but disclaimed beneficial ownership. Because the Shares are no longer held by Woolley Storage LLC, the ownership of the Shares will no longer be reported by Mr. Woolley.
